Deadline to register to vote

would you support its use in this Strategic Investment District?

TIF allows for investment today without burdening the current tax base, ensuring that future tax revenues support long-term growth. I strongly support Tax Increment Financing (TIF) as a valuable economic development tool—especially in areas like the Sycamore Mall Strategic Investment District—but it should not be the only tool we rely on. It has been an essential driver for successful projects across lowa City.


However, a sustainable economic development strategy requires more than TIF alone. I have worked with multiple government entities to discuss alternative economic development structures, including pursuing TIF alternatives for rural communities. Cities must explore additional funding sources like Community Development Block Grants (CDBG), infrastructure investment programs, and private-public partnerships to diversify revenue streams and avoid overreliance on any single mechanism.

I fully support the Greater lowa City, Inc. approach of combining private investment, targeted city support, and strategic infrastructure improvements to revitalize key districts. Economic growth happens when we balance incentives, streamline processes, and foster collaboration among businesses, developers, and city leaders.

lowa City's future depends on smart, strategic investment—TIF is an excellent tool, but it should be part of a broader strategy that ensures long-term success and sustainability for our business community.

What do you hope to accomplish on the Iowa City City Council

and how will it benefit the business community?

I hope to do everything I can to improve the material conditions of working people of lowa City, to defend our most vulnerable, to embolden grassroots organizing, and create a more just and equitable community. When the working class have affordable housing, affordable childcare, affordable utilities, free public transit, etc, they have more disposable income to spend as a whole, and especially more money to spend on our local shops that add to our cities character. I wish to combat the hold that just a few landlords and real estate entities have on the commercial property around lowa City, and especially downtown. I wish to look into policies, like right of first refusal, to provide local business owners the critical opportunity to purchase the units that they run their business out of, and could also play a part in curtailing the rising costs of commercial (or residential) leasing. When people have better lives, have more free time and more leeway in their budgets, they have the ability not only to spend more money, but to engage in community in ways that make it a more attractive place for businesses and people alike to call home.

As a founding member of the Iowa City Tenants Union, I have been in the same room with landlords who were actively engaging in fraud and abuse directed at their tenants, and held professionalism and composure in these negotiations. As a mediator, I know how to negotiate productively even with those I strongly disagree with, or even personally dislike. Putting aside emotion or personal grievance when the interests of the community are on the line is a core priority, and a skill that I have learned through my decade of community work in lowa City. Going into conversations with good faith intentions, while assuming the same from the other party, is the baseline starting point in every meeting I engage in.

would you support its use in this Strategic Investment District?

With potential budget shortfalls coming in the near future, being more creative and getting more value out of our public dollars is something we need to be exploring. The future tax revenue the city can accrue from developments using Tax Increment Financing definitely has that potential, and needs to be explored. I believe that the community having a stake in development as a whole is extremely important to further democratizing our city. We need to make sure that when the city uses our residents tax dollars in development, it comes with mechanisms to ensure that the development is of long term benefit for the community, both in utility and potential tax revenue. We need to make sure to address the risk of potential development causing gentrification and pricing out low income residents by exploring ways to keep housing affordable in the area. If such mechanisms are in place, and if the public gets a good cut of the deal, I will definitely be in favor of using TIF to deliver much needed attention and improvements to the area surrounding Sycamore Mall.
